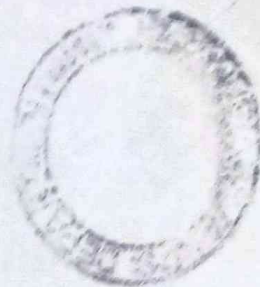
THE SALESIAN ANDHRA SOCIETY

Registered under the Societies Registration Act 1860 (Act XXI of 1860)

MEMORANDUM OF ASSOCIATION.

1. Name: The name of the Society is THE SALESIAN ANDHRA SOCIETY.
2. Office: The Registered Office of the Society shall be in Andhradesa, and for the time being in St. Aloysius' High School, Visakhapatnam.
3. Objects: The objects of the Society are:-
 - a) To take charge and manage all the temporal affairs of the Missionaries of St. Francis de Sales in Andhradesa, in Orissa, as well as anywhere else in India Where the Missionaries of St. Francis de Sales may have possessions, institutions, or works.
 - b. To promote the spiritual, temporal, educational, industrial, technical, agricultural, and others interests of the said Missionaries of St. Francis de Sales in the places above-noted, of the Institutions under their control, and of the people who work with them.
4. Means. The means employed for the attainment of these objects are:-
 - (1) The provision and maintenance of:
 - (a) -Elementary and secondary schools, industrial, technical, agricultural and training schools, whether recognised or not by Government.
 - (b) -Churches, chapels, convents, monasteries, novitiates, missions founding homes, orphanages, penitentiaries, and similar undertakings.
 - (c) -Colleges, hostels, boarding houses, reading rooms, libraries, or any other connected institutions.
 - (d) -Workshops, shops, banks, printing presses, cinemas, agricultural settlements, Cooperative societies, hospitals, dispensaries, clubs, and similar activities.
 - (e) Any other religious, educational, and charitable institutions.
 - (2) The supply and maintenance of the personnel thereof and of all the necessary implements to carry on the objects of the Society in accordance with Canon Law, the Constitutions of the Missionaries of St. Francis de Sales and the Government rules and regulations in force in the places where the Society works.
 - (3) The raising of funds by subscriptions, donations, or other means for the above objects, and administering the funds thus raised.

(4) The management, improvement and development of any part of the properties personal or real which at any time or in any manner may come to or vest in the society, and to sell, mortgage, or otherwise dispose of the same as the necessity or the advantages of the society may require.

(5) Taking over the effects and liabilities of other institutions.

(6) The doing of all such things as are incidental or conducive to the attainment of the above objects, or of any of them.

(4) The Governing Body, to whom by the Rules and Regulations of the Society the management of its affairs is entrusted, shall consist of (1) the President, (2) the Treasurer, (3) the Secretary, (4) the members appointed by the president for this purpose. The President and the Treasurer are ex-officio members, the other are nominated members, as per rules and regulations hereinafter.
